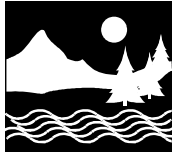

# Hartland Recreation Department Scholarship Fund Policy

### Scholarship Policy

- Requests must be accompanied by either current W2(s), Federal Income Tax form or Unemployment Annual Statement
- Scholarships are not available to non-residents.
- Foster children are eligible, providing they are living in a resident household.
- Scholarships are available for instructional classes, town organized/sponsored youth sports, youth after school programs and summer camps.
- Scholarships are limited to one activity per individual per season (fall, winter, spring and summer) for a total of four (4) per year.
- All scholarships shall be approved or denied by the Hartland Recreation Department Director.
- Preference to applications will be given to those who are directly referred by a social service agency or school (SEVCA, Family Place, VT Department of Social Services, Churches, Haven, etc.)
- Applicants will be notified by mail or by telephone prior to the activity starting, provided the application form was received by the established activity/program registration deadline.
